

# **EAGERTRIEVE KENNELS**

## **Placement Contract**

**Eagertrieve Kennels** occasionally finds that it is advantageous to place certain “pick” puppies with individual homes. This can be a twofold benefit to the puppy/dog as well as to the prospective foster puppy owners.

First, the puppy/dog has the benefit of growing to its emotional and physical potential within a family environment. Also, the prospective foster family has the opportunity of obtaining a “pick of the litter” puppy at no initial financial expenditure.

1. The puppy/dog will be placed with the foster family at no financial cost. The puppy/dog remains the property of **Jolene Klotz** on the registration papers.
2. The puppy vaccinations will be done at the **Wetaskiwin Animal Clinic** at the cost of the breeder. If the foster family is unable to accommodate the times chosen they may use their own veterinarian and the costs shall be that of the foster family.
3. Yearly vaccinations and eye clearance checks shall be the responsibility of **Eagertrieve Kennels**.
4. At two years of age or older, the dog will be OFA certified. This cost shall be borne by **Eagertrieve Kennels** and will be performed at the **Wetaskiwin Animal Clinic**.
5. Any accidents occurring while the dog is part of the foster family or any surgery required due to injury shall be at the expense of the foster family.
6. The dog must be placed on Pet Insurance by the foster family to cover any possible incidental expenses that may arise.
7. Feeding and day to day expenses shall be at the expense of the foster family. The dog must be fed premium quality dog food and must NOT become overweight.
8. A suitable crate shall be purchased by the foster family for the puppy/dog.
9. If **Eagertrieve Kennels** chooses to show the dog it shall be at **Eagertrieve Kennels** expense.
10. After the female has her eye and hip certifications, she shall be returned to **Eagertrieve Kennels** for one litter a year if required. She shall have her puppies at **Eagertrieve Kennels** and following weaning, she shall be returned to the foster family.(4 litters max)
11. In the case of a male, he shall be returned whenever **Eagertrieve Kennels** requires him to be used at stud.
12. If the dog does not clear its hips, eyes or elbows, but is completely physically sound, the foster family will have first right to purchase the dog for the going rate of Eagertrieve puppies to the foster family. At that time, **Eagertrieve Kennels** relinquishes all financial rights or obligations for that dog. It is also understood that the aforementioned dog carries no guarantees.
13. If the dog is physically unsound due to dysplasia or any other genetic conditions, the breeder will transfer ownership to the foster family for no purchase cost and it will be the responsibility of the foster family to look after the dog to his or her best interest.
14. If the breeder decides the dog will not be a good fit for her breeding program for any reason, the foster family will be given first right to purchase outright at the current pet price her pups sell for.
15. **Eagertrieve Kennels** will board the foster dog free of charge with as much notice as possible.
16. If at any time, the foster family is unable to retain the puppy/dog, it shall be returned to **Eagertrieve Kennels** gratis.
17. If it becomes evident that the puppy/dog is not being housed or cared for in its best interest, the dog shall be returned intact to **Eagertrieve Kennels** upon request with no financial remuneration being paid of its return.

18. The dog shall not be used for breeding purposes by the foster family or it shall be returned to **Eagertrieve Kennels**.
19. Once the dog is deemed retired by the breeder, the foster family is responsible for the cost of the spay/neuter, and once it is complete, they shall send a copy of the invoice or Certificate of Sterility to the breeder which then the CKC papers will be transferred to the foster family. No more obligations.
20. If the dog is accidentally killed, the foster family agrees to pay Eagertrieve Labradors current pet price. This is not a punishment, but a pre-estimate of the breeders financial damages.
